



2021 California ProStart Cup Participant Waiver & Release Form

I understand I hold the California Restaurant Foundation, the California Restaurant Association, CRF or CRF affiliated entity, their officers, and agents and employees (“CRF”) harmless from any and all liability or claims, which may arise out of or in connection with my participation in the 2021 California ProStart Cup competition (“Activity”). I fully understand participants are to abide by all rules and regulations governing conduct during the competition. Any violation of these rules and regulations may result in that individual being disqualified from the Activity.

Misconduct, which includes but is not limited to any drug or alcohol use during the Activity, may disqualify a participant from awards or further participation. Should any misconduct come to CRF's attention, the matter will be investigated, as CRF deems appropriate. Any decision and sanction as to appropriate action due to misconduct is at the sole discretion of CRF and is final. By entering into the contest, the student accepts this requirement as well as all other conditions of the program.

I hereby consent that the CRF, its representatives, successors or assigns, shall have the right to publish or use any photographs, movie films, video tapes, digital images and/or sound recordings, submitted text or any part thereof, they have taken or made of me in connection with the Activity or in which I may have included, for publicity, advertising, Internet usage or any other lawful purpose in conjunction with my own or a fictitious name, or in reproductions thereof in color. Students who provide an email address will receive information on scholarship, job and volunteer opportunities from CRF.

I hereby expressly waive and release any and all claims which I may have, or which I may hereafter have, against CRF arising out of or attributable to the Activity, including but not limited to while at school or at my residence. I understand that CRF will not be held liable for any damages incurred while preparing for, practicing and competing in the Activity. I covenant not to make or bring any such claim against CRF and forever release and discharge CRF from liability under such claims. I acknowledge that there is no compensation provided to participants in the Activity. I hereby warrant I have every right to contract in my own name in the above regard. I state further I have read the above authorization and release, prior to its execution, and I am fully familiar with the contents thereof.

This form must be completed and signed before students are eligible to participate in the CRF's ProStart® Competition. BY SIGNING BELOW, I (AND THE PARENTS OF MINORS) ACKNOWLEDGE THAT I HAVE READ AND FULLY UNDERSTOOD ALL OF THE TERMS OF THIS RELEASE AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE CRF FOR CLAIMS ARISING OUT OF THE ACTIVITY.
